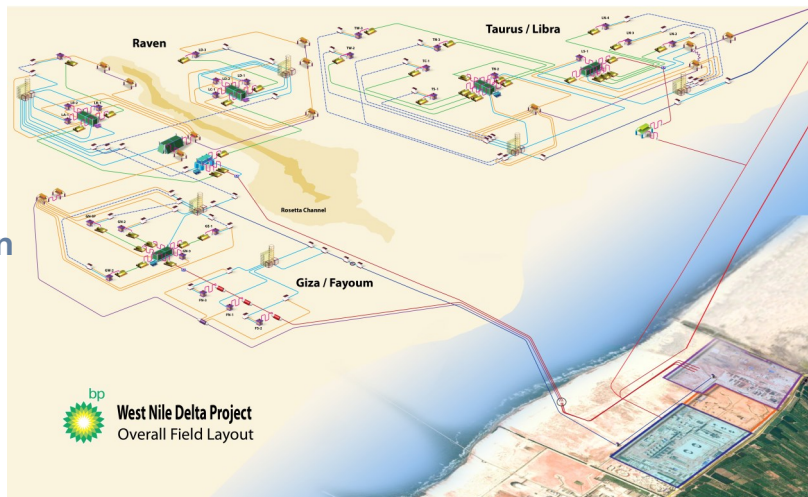

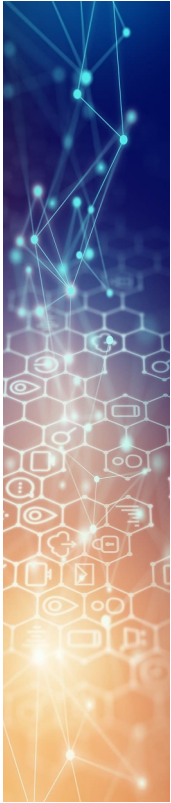


Our Offices

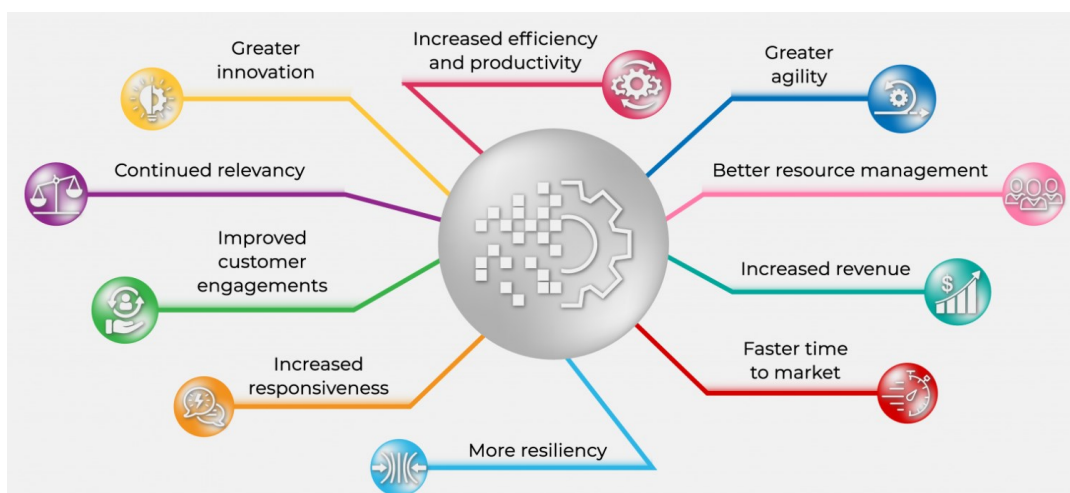
